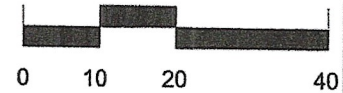


Recommended Run Times (minutes)

Recommended Monthly Cycles

(Water Days)

| • January | 3 | Water Budget |
| • February | 3 | Zone 1(spray) – 8gpm, 1.2in/hr |
| • March | 4 | Zone 2(spray) – 10gpm, 1.5 in/hr |
| • April | 4 | Zone 3(bubbler) – 2gmp, 2.7 in/hr |
| • May | 7 | Zone 4(spray) – 11gpm, 1.55 in/hr |
| • June | 9 | Zone 5(spray) – 9gpm, 1.4 in/hr |
| • July | 11 | Zone 6(spray) – 9gpm, 1.3 in/hr |
| • August | 11 | Zone 7(rotor) – 11 gpm, .6in/hr |
| • September | 9 | Zone 8(rotor) – 11 gpm, .6 in/hr |
| • October | 6 | Zone 9(rotor) – 12 gpm, .65 in/hr |

Recommended Maintenance

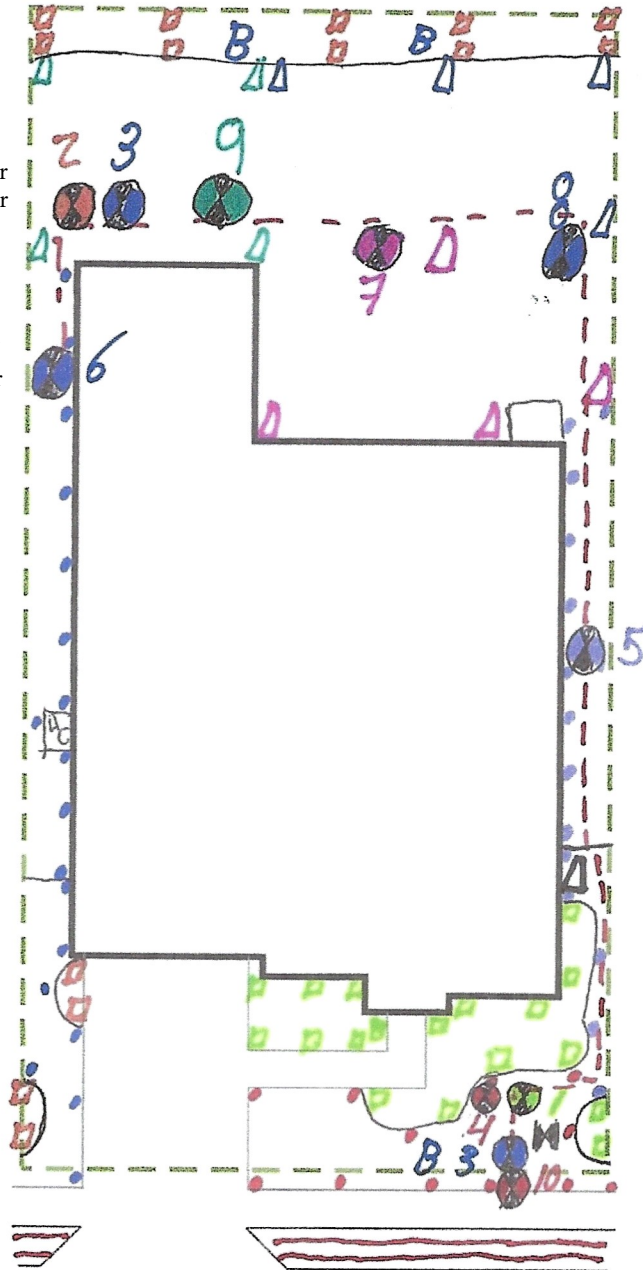
- Backflow – Test Annually
- Filter – Check Annually for debris
- Heads – Run system monthly checking for leaks or broken heads
- Valve Covers – Trim grass to keep exposed
- Controller – Seasonal update programming
- Winter – Run system briefly every 2 weeks if system turned off

COMPLETION ITEMS PROVIDED

- The manufacturer's manual for the controller.
- A seasonal watering schedule.
- A list of components that require maintenance and the recommended frequency of maintenance.
- A permanent sticker has been attached to the controller indicating the warranty period for the irrigation system and contact information.
- The corrected or re-drawn design plans indicating the actual installation and components of the system.
- Location and operation of the isolation valve.
